Council meetings dealing with planning and general purpose issues are normally held on the third Thursday of each month (except for May, August and sometimes December). Agendas are also available – there is an electronic mailing list, and they can also be viewed on all the noticeboards, at the libraries, at Shelley & Burton Village Halls and at Flockton & Grange Moor post offices. Minutes are at the libraries and posted on the website. All documents can be requested from the Clerk.



Chairman's Overview of the Year

For me, this year has been a year of consolidation and the final coming together of a number of major projects that have taken some time to complete.

- We are at last in the process of completing the sale of Shelley Village
 Hall on a leasehold basis to the Shelley Community Association. After
 many months of negotiation, I am delighted to report that I am confident that we
 should be able to complete the transaction quite soon.
- The much needed extra work on Kirkheaton Churchyard is well in hand, with necessary tree surgery already completed in the Spring. The maintenance of the footpath and further works to the boundary wall are just awaiting a Faculty agreement from the Diocese, so we hope to see the work completed over the summer.
- The Council undertook two sets of improvement work at Grange Moor allotments with extra plots having been made available and all taken up; plus additional work to improve the drainage and top soil is ongoing. I must mention the hard work and many hours of their own time put in by Councillors Paxton, Barraclough and Whittingham on this project.
- The final touches to our new website are just being finalised and a Beta version should be live quite soon. I must give our sincere thanks and gratitude to Mr Adrian Royle (the Clerk's Husband) who not only built the current one, but has also hosted and maintained it at his own expense since 2004. We are in his debt.
- We have been pleased to add reciprocal links to and from various community and other not-for-profit organisations on the existing website. This helps to improve the flow of communication and information. If your group is not already represented and you would like to be included, please contact the Clerk, who will be most happy to oblige.

Also this year, we have seen the whole Council continue to work together as one team and not as groups of political parties just scoring points, as in previous Councils. I must praise my predecessors for all the hard work they put in to make this happen. I just hope the new Council continues this trend, as a lot more good work for the community can be done more efficiently and enjoyably for all.

We reduced the precept by £5,000 over the previous year, whilst increasing our support for the parish community, at a time when local funding is needed even more. Our Community Project Grants are at their highest level ever.

We had a most successful and enjoyable day at the Honley Show last summer, where we shared a stand with our colleagues from Holme Valley Parish Council. It was a fabulously sunny day and I was able to meet and talk about the Council and what we do with many members of our community who came to visit us, as well as comparing notes with our colleagues from the Holme Valley.





We had a second very successful Environment Fayre in September. It was a pleasure to welcome the Mayor of Kirklees, Cllr Andrew Palfreeman, who graciously agreed to open the event and who visited all the stalls. Another welcome visitor was our new MP, Simon Reevell. My thanks to Cllr Michelle Atkinson, Chairman of the Environment Committee, and her team, who put it all together.

I was also delighted to be able to hold my Civic Service at the beautiful St John's Church in Lepton. The day was wonderful. We were blessed with fine weather, honoured again with the presence of the Mayor of Kirklees and the Mayors and Chairmen of all our fellow Town and Parish Councils and their consorts. We were entertained royally by the Emley Brass Band, both before and after the service and the whole event was managed brilliantly by



our new vicar, the lovely Rev'd Anita Raggett, to whom I will be forever grateful. I must also make a special and sincere thank you to the Lepton Music Group who led the singing during the service and for the beautiful piece they performed during the service.


I would like to welcome the residents from the section of Thurstonland, which was brought back into the fold, following the boundary changes last May. I hope that now the whole village is in the same Parish Council, things will run a lot more smoothly and simply for them.

At the conclusion of this 4-year Parish Council term, I must pay tribute and give my thanks to the other Councillors, who have worked so tirelessly and hard over the term, with particular thanks to those who are standing down this time. I would also like to thank them all for electing me as their Chairman for this final year. It has been both an honour and a humbling experience.

One special mention must be to ClIr Richard Burton, who has worked so hard behind the scenes as Line Manager during this Council. The role has taken up a great deal of his personal time in the day to day management of the staff on our behalf. His work has resulted in a rising of the Council's standards regarding employment issues.

A sincere vote of thanks must also be given to Cllr Lin Holroyd, who throughout the Council has produced and edited the Council's quarterly newsletter, One Voice. An onerous task, which she has executed with her usual good humour and efficiency.

And, I could not possibly finish this report, without saying a big public thank you to the Parish Council's Administrative Assistant, Sandra Harling, who is retiring at the end of June. Sandra has been with the Council for 7½ years and will be missed. However, I am sure we will see her on the odd occasion in the public gallery, making sure the next Council behaves. Thank you, on behalf of everyone for all your hard work and dedication.

In total, £16,592 was awarded in annual small grants & emergency grants. The individual payments are listed above, which were used to finance a whole range of different activities across the whole spectrum of ages and interests. Community organisations are invited to apply for small grants in the autumn each year and are entitled to £250 every year. It can be taken in larger amounts so long as the total awarded over any three consecutive years does not exceed £750. Forms become available in September and must be returned with the financial information by the last Friday in October. Churches are awarded £200 to contribute towards the maintenance of the church clock subject to receipt of a completed form by the October deadline. Each community organisation is also entitled to apply for up to £750 in emergency grant funding. Full details of how to apply are available on request and from the website.

The various photographs throughout this report show the range of projects which have been funded, and serve to inform groups of the kinds of things the Parish Council supports.

The Environment

The Environment Committee continued to develop the Environment Plan and build on the work carried out over the previous 3 years of this term of office. As well as awarding environment grants to community organisations with a range of interesting and worthwhile projects, it also involved a continuation of the kind of work so well established during this term of office. Members worked with Kirklees officers in the Countryside and Environment Units – Mr Neil Windett, the Countryside Unit Manager is a valued co-opted member of the Committee. He attends most meetings and provides members with lots of useful information on all kinds of related subjects. His colleague, Mr Andy Wickham,

attended one meeting and gave a most interesting presentation on the work of the Countryside Unit and his role within the Unit. Details on environment projects taking place in the Parish were highlighted. Other co-optees

include Kate Woolley, a local interested resident and Tim Scott, who represents both Kirkburton & Highburton Community Association and the Kirkburton & District Civic Society.

The Committee decided to repeat the school sunflower competition and the Environment Fayre, with equally pleasing results. Thanks are due to Cllr Paxton and Cllr Holroyd who along with Sandra Harling, were responsible for sorting out all the equipment needed by each school, and sharing the delivery of the items with Cllr Atkinson. Where it fitted in with the school, Cllr Atkinson gave presentations to school children highlighting to them the importance of sunflowers and the all-important seeds as well as talking in more general terms of the environment and the children's role in safeguarding it for the future.



We are most grateful to Jonathan Walker, owner of the Colne Valley Garden Centre, who donated some of the equipment and sold the rest at a reduced price. He also gave up his time on a busy Saturday to act as judge, carefully measuring each entry as the children arrived, eagerly clutching their sunflowers and desperately hoping theirs was the winning entry.



The Environment Fayre took place alongside the competition judging. The Hub was a hive of activity as various community groups, the local Police, Kirklees officers, the Yorkshire Wildlife Trust, White Rose Forest, Walkers Are Welcome, the Energy Saving Trust, to name but a few, all turned up with stands and all manner of items and information to populate the Hub, alongside the Council's own information and photographs, which



had been prepared by Angela Royle and Cllr Michelle Atkinson. There were also details on allotments and growing vegetables together with samples of the real thing! Caro Ward provided children's craft activities on the theme, and refreshments were kindly provided by volunteers from the Denby Dale Centre, who owns the Hub. The building

itself had been suitably decorated by Cllr Atkinson and others with wildflowers, leaves, herbs, wild fruits having the effect of really bringing nature into the Hub that morning.



The day was run by the Councillors, who enjoyed meeting their residents, young and old alike. We were most grateful to Cllr Palfreeman, Mayor of Kirklees, for opening the event and to our MP, Simon Reevell, for also turning out and contributing to the success of the day. Thanks are also due to Ian Lumb, who provided lots of wonderful photos of the event and also to CV Graphics for the printing.



The level of grant funding awarded to groups increased, partly due to people becoming more aware of the possibilities of applying for them, as the individual Councillors further developed their relations with groups within their areas.

Working Together

The Council has continued its tradition of working alongside other organisations and its partners, including the other 4 Parish/Town Councils in Kirklees, various different departments and officers at Kirklees Council, Metro, EPIP (Leader Programme). The Council is grateful to officers and members of all these organisations, for the help and support it has received during this term of office. We also value associations with all of the community groups in the Parish such as Lepton Link, Kirkheaton PCC, Shelley Community Association and

many other community groups throughout the whole of the Parish, most of whom are in regular contact with the Council & the local Councillors, which has led to benefits to the villages and their residents. Thank you to all of you who have contributed in some way to the well being of the Parish and its villages. Projects such as those which were organised by the community groups at Thurstonland and Farnley Tyas and supported with community grants (included in the list) also involved Kirklees officers working alongside the group representatives and local Parish Councillors, proving that teamwork definitely is the best way forward.

Also at Shepley, the Council contributed towards the costs of a restoration project at the Methodist Church, for which EPIP was the major funder. The graveyard was overgrown with paths undulating with potholes and debris. A number of tree stumps were removed and a significant amount of broken stone was also taken away, fencing at one end of the graveyard was replaced. A seating area will be provided and new planting has taken place. The Reverend Ben Chambers, who was involved in the founding of both Everton and Liverpool Football Clubs, is buried here.



Work on the Parish Walks project also continues by Cllrs on the Kirkburton Walkers Are Welcome Sub-Committee working with EPIP's officers to develop this very complex project on 10 walks, including benches, milestones & finger posts. Full details can be seen on the website www.kirkburtonparishwalks.co.uk

Digitization of the Council's records was another project which benefitted from 100% funding from EPIP. Although the Parish Council only goes back to 1974, some of the records in the office are much older, eg there are the old auction papers dated around 1919 covering the sale of the land at Shepley, some of which is now the Council's allotments. We also have photographs and various other documents relating to charity foundations, as well as the minutes from the Parish Council and other Council documents. These are now all on a hard drive. It may be possible to put them up on a website in the future so they will be more easily accessible by the public, if funding can be found for the project. Documents which are lodged at the Wakefield Public

Records Office are due to be assessed in terms of interest to the public. It is hoped to have at least some of those digitised during the course of the coming year. If you have any interest in any particular type of document, it would be helpful if you could let us know, and we will bear your comments in mind.
