**CG22 Apologies and
Declarations of
Interest**

The following personal declaration was declared: Cllr Beresford in Lepton Methodist Church, as he is involved with many of the groups which meet there.

Cllr Burton declared a prejudicial interest in Lepton Methodist Church as he is a member. He left the meeting whilst this application was considered.

Resolved: To hold all items in public.

**CG24 Admission of the
Public**

Members considered the following applications which had been deferred from the November 2011 meeting, as an exception as they did not comply with the new rules, which had been recently introduced.

**CG25 Small Annual
Grants**

Members considered the application from Shepley Junior Cricket Club for £750 to contribute towards the costs of coach training courses, CRB checking, First Aid training and ground rental.

**CG26 a) Shepley Junior
Cricket Club**

Recommendation: To award a Start Up Grant of £100 to Shepley Junior Cricket Club to contribute towards the above costs, as Club has not been in operation long enough to qualify for a Small Annual Grant.

Members considered the application for £250 from Shepley Women's Institute towards the costs of speakers, rent of library and travelling costs to regional meetings.

**CG27 b) Shepley
Women's Institute**

Recommendation: That the Council awards a Small Annual Grant of £250 to Shepley Women's Institute for the purposes described above.

Members considered the application for £3,000 towards the costs of a concert tour to the Rhineland in Germany. It was noted that this application has been received retrospectively and only one quote has been obtained when the requirement is for three quotes to be obtained.

**CG28 Community Project
Grants:

Shepley Band**

Recommendation: That the Council refuses the application for £3,000 to Shepley Band as the rules have not been followed and the criteria has not been met.

Cllr Burton left the meeting.

**CG29 Lepton Methodist
Church**

Members considered the application for £3,000 towards the costs of essential roof repairs at Lepton Methodist Church.

Recommendation: To award Lepton Methodist Church £3,000 towards the costs of essential roof repairs.

Recommendation: Lepton Methodist Church to be informed that the award is recognising the broader community role that it plays.
