22/93843 Demolition and partial reinstatement of dry stone wall, engineering works to level access and erection of new gate (within a Conservation Area) at Meadow Barn, 16 Manor Road, Farnley Tyas.

The Council objected on the grounds of highways and detrimental impact on the visual amenity. The proposed new access to the site is located on one of the narrowest sections of Manor Road on the outer curve of a bend, and the current application does not indicate any proposals for the provision of highway standard access requirements or visibility splays. Such measures would be necessary to ensure safe access to and from the site, but the major engineering work required to achieve these standards would have a detrimental effect on the existing street scene.
