New Year and New Start for the Council

May saw the Annual Meeting marking the start of this new 4-year term of office. Cllr Sharon Dunford and Cllr Richard Burton were elected as Chairman and Vice Chairman (Photo shows Cllr Dunford presenting Cllr Burton with his Vice Chairman's medallion). Cllr Dunford was first elected to Council in 2007 and was proud to be the first Chairman this term. "I'm so pleased that all the Councillors who stood for re-election were returned by the electorate. This speaks volumes about how the communities have seen our achievements over the last four years and is the best accolade that we could have had. I'm sure that we all look forward to serving our communities in the best possible way over the next four years." She encouraged the public to be in contact if they had any ideas for particular projects in the future and was sure that the new Councillors would join in supporting the communities.



Thank You to all the Councillors who retired at the last elections. This included 3 past Chairmen and several members who had served the Council for 8 years or more. Those still in office offered their gratitude to all of them for their contributions over many years. Cllr Dunford said, "We all hope that we will be able to build on their achievements during the course of the next term of office, so the Parish Council really will make a difference to its communities and residents." She added, "I would like to thank all of those who stood down at the election for their efforts, but particularly Cllr Lin Holroyd, for all the time and effort she put into producing the newsletter over the last 4 years. She also worked particularly hard on the issues at Kirkheaton Churchyard, and we are most grateful to her."

The general reserve figure is at the bottom of the range legally required to be maintained by Parish Councils under the Accounts and Audit Regulations 2007. The full accounts can be viewed on the website.



Grants: The total amount awarded this year is the most the Council has ever awarded, representing 60% of the precept. Even with a decrease in the precept the Council found ways and means of supporting the community groups, which needed funding to continue with their valuable work when grants from other bodies were becoming more difficult

to access. The full breakdown of awards can be found in the main report along with photographs of sponsored projects, a selection of which has been included here. We are most grateful to all the groups and clubs for the many cards/letters of thanks & photographs we have received throughout the year, showing how well the money has been spent and what a valuable contribution the Parish Council



makes to so many voluntary and not-for-profit organisations.

All meetings have a public participation session & the full meeting is open to the public.

It has been another busy year with the focus on bringing matters to a conclusion and consolidating in readiness for the new Council term. Projects receiving attention included Grange Moor allotments, where 2 large sections and a smaller section have been cleared. This has increased the number of plots available, drastically reducing the waiting list. Further work is planned to address the drainage problem .

We are pleased to welcome to Kirkburton Parish the people, who live in Thurstonland and were previously within the Holme Valley PC area. This small boundary change has brought the whole village into one municipal area, which we hope will make things simpler for you all. We have inherited a seat there, which was previously



owned by Holme Valley PC, who have kindly handed it over to Kirkburton.

The Council continues to care for its public seats – some in Flockton & Lepton were repaired and new seats are currently on order for Grange Moor, Farnley Tyas and Flockton.



Maintenance & repair work is continuing at Kirkheaton Churchyard. The grass was cut regularly over the summer and a significant amount of tree felling and pruning took place in the early Spring. This has kept the area neat and tidy for visitors, who come for a variety of reasons, including to enjoy the


quiet tranquility of nature, even though it is situated so close to the hustle & bustle of village life. Rev Steel, the Rector, sent his compliments and thanks to the Council for the work. Repairs to walls & paths are due to take place in the summer.



Last September saw the second Environment Fayre and judging of the Sunflower Competition at the Hub in Kirkburton, which was again a big success. A winner from each competing school was presented with a £20 WH Smith gift voucher. Many local community groups took part and exhibited their work on environment projects in this area, proving of interest to all ages.



Council has been working with EPIP & Walkers are Welcome to develop a series of walks across the Parish, which will include benches, finger posts & milestones. It is a complex project, which is gradually coming together. The first milestone (*right*) was recently installed.
